Financing Bank (FFB) announced the following activity for the month of March 2020.

FFB holdings of obligations issued, sold or guaranteed by other Federal agencies totaled \$78.1 billion on March 31, 2020, posting an increase of \$1.28 billion from the level on January 31, 2020. This net change was the result of an increase in the holdings of government-guaranteed loans of \$1.28 billion. The FFB made 134 disbursements and received 25 prepayments in the month of March.

The FFB also reset the interest rate for one loan to the United States Postal Service. In addition, the FFB re-priced and extended the maturities on 562 loans guaranteed by the Rural Utilities Service.

Attached to this release are tables presenting FFB March loan activity and FFB holdings as of March 31, 2020.
