Federal Financing Bank (FFB) announced the following activity for the month of March 2021.

FFB holdings of obligations issued, sold or guaranteed by other Federal agencies totaled \$81 billion on March 31, 2021, posting a decrease of \$1.7 billion from the level on February 28, 2021. This net change was the result of a decrease in the holdings of government-guaranteed loans of \$1.7 billion. The FFB made 72 disbursements and receive 692 prepayments in the month of March.

The FFB also reset the interest rate for 1 loan guaranteed by the United States Postal Service during the month. There were 427 maturity extensions for the month of March.
