Federal Financing Bank (FFB) announced the following activity for the month of May 2021.

FFB holdings of obligations issued, sold or guaranteed by other Federal agencies totaled \$79.1 billion on May 31, 2021, posting an increase of \$781.6 million from the level on April 30, 2021. This net change was the result of an increase in the holdings of government-guaranteed loans of \$781.6 million. The FFB made 55 disbursements and received no prepayments in the month of May.

The FFB also reset the interest rate for 5 loans guaranteed by the United States Postal Service during the month. There were 5 maturity extensions for the month of May.
