Federal Financing Bank (FFB) announced the following activity for the month of April 2022.

FFB holdings of obligations issued, sold or guaranteed by other Federal agencies totaled \$80.5 billion on April 30, 2022, posting a decrease of \$644.5 million from the level on March 31, 2022. This net change was the result of a decrease in the holdings of government-guaranteed loans of \$644.5 million. The FFB made 74 disbursements and received 4 prepayments in the month of April.

The FFB also reset the interest rate for 21 loans guaranteed by the Department of Energy during the month. There were 23 maturity extensions for the month of April.
