Federal Financing Bank (FFB) announced the following activity for the month of March 2023.

FFB holdings of obligations issued, sold or guaranteed by other Federal agencies totaled \$84.5 billion on March 31, 2023, posting an increase of \$257.6 million from the level on February 28, 2023. This net change was the result of an increase in the holdings of government-guaranteed loans of \$257.6 million. The FFB made 64 disbursements and received 3 prepayments in the month of March.

The FFB also reset the interest rate for 1 loan guaranteed by the United States Postal Service. There were 338 maturity extensions for the month of March.
