Federal Financing Bank (FFB) announced the following activity for the month of April 2023.

FFB holdings of obligations issued, sold or guaranteed by other Federal agencies totaled \$85.8 billion on April 30, 2023, posting an increase of \$1.36 billion from the level on March 31, 2023. This net change was the result of an increase in the holdings of government-guaranteed loans and agency debt of \$1.36 billion. The FFB made 49 disbursements and received 1 prepayment in the month of April.

The FFB also reset the interest rate for 21 loans guaranteed by the Department of Energy during the month. There were 23 maturity extensions for the month of April.
