Federal Financing Bank (FFB) announced the following activity for the month of September 2023.

FFB holdings of obligations issued, sold or guaranteed by other Federal agencies totaled \$138.7 billion on September 30, 2023, posting an increase of \$51.7 billion from the level on August 31, 2023. This net change was the result of an increase in the holdings of government-guaranteed loans of \$51.7 billion. The FFB made 74 disbursements and received 5 prepayments in the month of September.

The FFB also reset the interest rate for 1 loan guaranteed by the United States Postal Service during the month. There was 1 maturity extension for the month of September.
