Federal Financing Bank (FFB) announced the following activity for the month of June 2024.

FFB holdings of obligations issued, sold or guaranteed by other Federal agencies totaled \$184.8 billion on June 30, 2024, posting an increase of \$729 million from the level on May 31, 2024. This net change was the result of an increase in the holdings of government-guaranteed loans and agency debt of \$729 million. The FFB made 39 disbursements and received 8 prepayments in the month of June.

The FFB also reset the interest rate for 1 loan guaranteed by the United States Postal Service during the month. There was 1 maturity extension for the month of June.
